



Where Is The Ideal Meeting Location?

Since September of 2005 the RWCDS meetings have been held at the North Ridge Country Club (NRCC). The NRCC has been a huge venue improvement compared to the NC State Faculty Club, which was our home prior to the change. **Dr. Craig Adams**, the 2005 RWCDS President, was instrumental in negotiating favorable terms with the NRCC and getting the job done. NRCC is an elegant facility that offers excellent meeting rooms, delicious food, a superb service staff and an attentive management team. Since the change the meeting attendance has vastly increased (double to triple) and continues to grow.

The only perceived shortcoming is NRCC's location being in the northern part of Wake County (2.4 miles north of the I-440 Beltline). The 2005 Executive Board was cognizant of this factor when the change of location decision was made and every board since has discussed this issue and looked into suitable alternatives. The Boards have been aware of an undercurrent of dissatisfaction by some members practicing and /or residing in the southern part of the county.

To date a satisfactory alternative venue for a more centralized meeting site has not been identified. In addition to location and the factors mentioned above, obviously cost is a significant part of the equation. The relative good value that the society is enjoying at the NRCC has come to light during the course of the board's evaluation of other meeting sites.

The Executive Board is open to changing meeting venues to a more centralized location (or to a southern county location on a rotating basis). But, until a venue is discovered that is near comparable in amenities and cost, there is no logic in making a change in 2009. There are numerous factors including consistent, high quality CE that contribute to an outstanding local dental society whether it is county wide or a smaller region. There is a considerable amount of sustained work that goes into the process. The Executive Board and I implore you to look at the big picture when electing to not attend meetings because of a little extra drive than you would ideally like or considering forming a more localized competing society.

As a larger, more representative, well functioning organized group we have a more powerful voice when we speak out on issues and minimize duplication of effort in pursuing good speakers or professional outreach. Our foes in the government and insurance worlds would like nothing better than for us to separate and divide ourselves. The Board and I eagerly want to hear all of your ideas, suggestions and requests on how the RWCDS can become an even better Society and better serve your needs. Suggestions for potential meeting sites are greatly appreciated.

As an aside, I work at a location close to Western Wake Medical Center. I don't find the drive to the NRCC to be particularly time consuming or inconvenient. I do notice the heavy traffic is traveling in the opposite direction and am thankful not to be part of the challenge.
